Welcome to Arts on the Credit! Launched in 2012, **Arts on the Credit** is an independent not for profit arts organization showcasing, promoting and mentoring local artists with original juried shows and community initiatives.

We are delighted to offer the following for the November 2023 ArtWorks, a holiday themed show.

- ArtWorks will be juried and curated for a spectacular representation of our local artists:
 - Original work by the artist
 - Creativity and originality
 - Reasonable and fair pricing
- A \$50 jury fee will be applied to non AOTC members.
- To fairly fulfill table requests, one covered/skirted table will be provided at no cost, additional covered/skirted tables will be available for \$20.

Dates, Hours, and Location: ArtWorks will be held in the ballroom at **The Waterside Inn**, 15 Stavebank Road South, Port Credit.

- Set up; Thursday, November 2nd, 4 p.m. to 7 p.m. and Friday, November 3rd, 2 p.m. to 6 p.m.
- VIP Evening; Friday November 3rd, 7 p.m. to 9 p.m.
- Show; Saturday, November 4th and Sunday, November 5th 11 a.m. to 5 p.m.

Eligibility: All original works of art created between 2021 and 2023, "Show Special" signs, "Markdowns", "Seconds" or other similar signs NOT to be shown. Arts on the Credit reserves the right, at its discretion, to take whatever action is necessary to enforce the above, including cancellation of Exhibitor's space and the full retention of the full amount paid by the Exhibitor. Failure to comply with this request could mean the Exhibitor would not be invited to future Arts on the Credit events.

Booth Sizes and Costs:

- Booths will be allocated by the Arts on the Credit committee for the most effective display of mediums. Decisions are final.
- Double and shared booths are not permitted.

INCLUDED in your booth fee is one skirted table, electricity (please bring extension cords and power bars), and your parking fees. Centre booths will be provided with back curtains. Grids are NOT provided and NO attachments to the walls or back curtains are permitted. We will again have an artists' lounge with coffee, tea & water for the duration of the show.

Submission: Artists must submit a bio, and 5 (five) hi-res, 300 dpi, images of their work that will be part of their booth presentation to contact@artsonthecredit.ca, no later than September 8th, 2023, where the application will be logged and forwarded for jurying and curation. If you are NOT an AOTC member for 2023, an jury fee of \$50 must be submitted with your application either by etransfer your fee to contact@artsonthecredit.ca or you can mail your cheque to "Arts on the Credit," to Elysia Prokopetz, 1306 Monaghan Circle, Mississauga, ON L5C 1R8. NSF Cheques (insufficient funds) will be subject to a \$50 penalty.

Jury fee is non-refundable and all applications will be reviewed and curated. Decisions are final.

Acceptance: Registration fees are due *ONLY* when you have been notified of your acceptance to the *Show*, **September 22nd**, **2023**. Fees not received by **September 29th**, **2023** will forfeit placement in the show. JPEG's provided with the accepted artists application will be used for promotional purposes.

Refunds: Written cancellations received by **October 13th, 2023,** will receive a 50% booth fee refund, cancellations after October 13th, 2023 will not be refunded. AOTC may consider a refund after October 13th if there are extraordinary circumstances.
